BARC ELECTRIC COOPERATIVE

COMMUNITY SOLAR ELECTRIC SERVICE SCHEDULE PV

1. AVAILABILITY & APPLICABILITY

The Cooperative offers to make available units of energy generated from a Cooperative-owned solar photovoltaic facility (the "Facility") on a subscription basis. The facility will be owned, operated, and maintained by the Cooperative or its affiliate.

Service is available on a voluntary basis to Cooperative members in good standing receiving electric service under Schedules A-U and B-U, provided that the facility is not fully subscribed. Customers may also be referred to as Subscribers in this schedule.

2. TYPE OF SERVICE

Single-phase, and three-phase where available, at available voltages.

TERMS OF SUBSCRIPTION

A block of community solar supply service energy is equal to 50 kilowatt hours (kWhs) per month. The number of blocks to which a Customer subscribes shall not exceed the equivalent of twenty-five percent (25%) of the Customer's Average Monthly Consumption (the "Subscription Cap"). Customers may only subscribe to blocks of energy for one account. If the Facility is not fully subscribed at the outset, the Cooperative may increase the Subscription Cap amounts on a non-discriminatory basis, or allow subscriptions on more than one Customer account, or both, until the Facility is fully subscribed.

Average Monthly Consumption is based on a service location's electric consumption for the previous twelve (12) months. For new construction, the calculation will be based on engineering estimates. All determinations by BARC are final.

The subscription period shall be for a period of twelve (12) months from the effective date of the Customer's subscription (a "Period"). No less than thirty (30) days prior to the conclusion of the initial Period, the Customer shall notify the Cooperative of its intent to cancel or renew the subscription for another twelve (12) month Period (a "Subscription Renewal"). The Customer may elect to increase (subject to availability) or decrease the size of the subscription (i.e. number of blocks) at the time the Customer provides renewal notice to BARC. If the Customer fails to provide timely notice of its intent to cancel or renew, the subscription shall automatically renew for the next successive twelve (12) month period at the same number of blocks.

Customers may transfer their subscriptions only to another eligible account in the Customer's name. Transfers shall take effect at the conclusion of the billing period in which notice was provided to the Cooperative. Except as otherwise provided, Customers may not assign, transfer, gift, bequeath, or otherwise transfer any of its rights or obligations under this Agreement to any other individual, account, or entity for any purpose.

Customers may voluntarily cancel their subscription only at the time of Subscription Renewal or upon voluntary disconnection of electric service. At the conclusion of the billing period in which notice of cancellation is provided, Customer shall pay all amounts due and owing to the Cooperative. If the Customer moves off of BARC's electric system or ceases to be an active member, the Customer's subscription shall automatically terminate at the end of the billing period in which said action takes place.

4. MONTHLY CHARGE

Community solar supply service is a fixed monthly charge starting on the effective date of the Customer's subscription and expiring on May 31, 2036. For initial subscribers at the project's outset, the subscription rate shall be calculated by using the Cooperative's current Electric Supply Service Charge plus no more than Two Dollars (\$2.00) per block (the "Fixed Block Charge"). For subsequent subscribers, including, but not limited to, those on a waiting list or subscribing to subsequent expansion phases, the rate for the Fixed Block Charge will be priced at the Cooperative's then-current Electric Supply Service Charges for 50 kWhs of energy, plus no more than Two Dollars (\$2.00) per block.

The Electric Supply Service Charges and WPCA for the equivalent number of kWhs shall not be charged to the subscriber under Schedule A-U or B-U. Community solar charges do not supplant any other charges due under the Cooperative's Terms and Conditions or other rate schedules. If a Customer's electric consumption in a given month falls below the amount of energy subscribed, the Customer shall still be responsible for paying the Fixed Block Charge for the number of blocks subscribed.

5. OTHER TERMS

Subscribers have no ownership, possession rights or control of the facility, and have no rights or obligations with respect to the maintenance or operation of the facility. This schedule does not convey to any Subscriber any right, title or interest in or to any portion of any property (tangible or intangible, real or personal) underlying or comprising any portion of the Facility.

Subscribers shall be precluded from utilizing the Cooperative's net metering rider (Schedule NEM).

¹ Subscriptions for customers subscribing to subsequent expansion phases shall be for a period of twenty (20) years from the effective date of the Customer's subscription.

Any and all environmental attributes associated with the Facility shall remain the property of the Cooperative. The term "environmental attributes" means and includes all rights, credits, benefits, emissions reductions, offsets, and allowances resulting from the environmental or renewable characteristics or attributes of the Facility or the avoidance of the emission of any greenhouse gas, chemical, or pollutant to the air, soil or water, which are deemed of value by the Cooperative, in each case now or hereafter created or recognized by any governmental authority or independent certification association and generated by or associated with the facility, including, without limitation, any renewable energy credits ("RECs") or similar rights arising under any federal or state renewable portfolio standard ("RPS"), and any credits, offsets, or similar rights arising under any federal or state carbon legislation or regulation or any voluntary or government-mandated carbon trading program.

Nothing in this schedule shall be deemed to alter or modify any rate, charge, term or condition of the electric service provided by the Cooperative to a Subscriber, or to modify in any way a Subscriber's rights and obligations as a member of the Cooperative. All other rates, charges, and Terms and Conditions of Electric Service shall remain subject to change in accordance with applicable law at any time and the action of the Cooperative's Board of Directors.
